Approval of September Minutes:

A motion was made by Andy Rieth to meet with Don Gloy on the problem and ask for the townships help with an ordinance. Andy Rieth and seconded by Edgar Reihl. The board approved and Mike Needham is going to look into it.

New Business:

Updates to the Klinger Lake Directory were discussed. It was decided that we should vote on the cover photo.

A proposed date of June 12th for the beach rep. picnic at the KLCC would be looked into.

Thanks to Edger Reihl and Mary Vogt for working to make our website better.

Andy Rieth reported he is working on the boat wash and boaters' safety class.

We received a \$1500 Clean Water grant thanks to the work Andy Rieth, Chris Bowers and Mike Needham did. We will need some volunteers to help on this and plan on using the radio and newspaper to advertise this.

When we have a date for the annual meeting the DNR would like to come and talk about the rules in general and on buoys.

Need to check on the status of the boat launch and paving. When it is done the sign and bench will need to be replaced. A motion was made to have Ashley Miller fix the frame of the sign by Chris Bowers and 2nd by Andy Rieth. The motion was passed.

Mike Needham will post rules for boating and swim rafts on the website.

Discussed problems with wakeboard boats but tabled the discussion until more info could be reviewed on the damage they do to the weeds.

Debbie Doe moved we adjourn, Katie Kitchen seconded the motion, all members approved and the meeting was adjourned at 8:36.
